Supreme Grand Royal Arch Chapter of Ireland's Report 2018

2018 was a sad year for the Supreme Grand Royal Arch Chapter of Ireland and Freemasonry in general with the passing of the Most Excellent and Supreme Grand King, M.E.Comp. Michael James Ward. Having loyally and graciously served Freemasonry for some fifty-five years Michael, as he was affectionately known, passed away suddenly but peacefully on 12th April 2018.

Michael was a devoted family man, a keen horticulturalist, specialising in the cultivation of prize-winning daffodils. Michael, who

regularly supported his Church was also a member of Kllternan Country Markets for many years.

He was Initiated into Freemasonry in 1963 and in the following years he attained high office in all branches in the Irish Constitution and served as the Most Excellent and Supreme Grand King of the Most Excellent and Supreme Grand Chapter of Ireland for eleven years prior to his passing. He held several honorary ranks in the Irish Constitution and in many other branches of Freemasonry throughout the world.

His knowledge and expertise of Freemasonry was invaluable, and he will be sadly missed. We will miss his friendship and company, but it is said that to live on in hearts left behind is not to die, but we in Freemasonry in Ireland will remember a man and a Freemason who truly has left his footprint in the sands of Irish Masonry.

During March the Assistant Grand King, represented the Supreme Grand Royal Arch Chapter of Ireland along with the Grand Registrar and their respective partners attended the Annual Installation Convocation of the Supreme Grand Royal Arch Chapter of Scotland and the Festival of the Vernal Equinox. There was a large attendance at the Convocation and the dinner that followed. The representatives of the Supreme Grand Chapter of Ireland were the gracious recipients of the generous hospitality of their hosts.

The May Convocation of Supreme Grand Chapter was held at the Walter Raleigh Hotel, Youghal, Co. Cork hosted by the District Grand Royal Arch Chapter of Munster, where we had an excellent attendance. Congratulations to the District Grand King, Officers and members of the District for the superb arrangements.

A service of thanksgiving took place during the meeting for the life of Most Excellent Companion Michael J. Ward, led by Rev. Edwin W. Hunter and Rev. Canon T. Henry Trimble. During the service M.E.Comp. Gordon Leathem BEM paid tribute extoling M.E.Comp. Michael's extensive Masonic career and the high esteem he was held throughout the Masonic fraternity.

Prior the above Convocation the Officers of the District Grand Chapter of Munster processed to their seats emblazoned in their new, recently acquired, colourful robes.

> The Companions of Youghal Royal Arch Chapter No. 68 entered carrying a "Royal Arch" to mark the 275th anniversary of the original procession down the main street of Youghal.

A periodical – Faulkner's Dublin Journal, dated 14 January 1744 – reported the following:

'A great St John's Day (27 December 1773) procession was held in the town of Youghal when the Masonic Lodge (No. 19, warranted in 1733) met, after which the procession left the lodge premises and marched through the town to the church for service. The town was en fete; ships in the harbour were decorated and fired a salute of guns, while flags and bunting were everywhere displayed. The procession was headed by a band of musick, deacons and wardens carried their mauls and badges of office, the worshipful master being preceded by a Royal Arch.'

As the September Convocation the Grand Director of Ceremonies presented M.E.Comp. S. Gordon Leathem BEM, Grand King elect, for installation. The Grand King elect's sponsors were M.E.Comp. Brian G. John Bell; Grand King's Standard Bearer E.Comp. Ronald G. Abbott and Grand Sword Bearer E.Comp. William R. Wallace.

The Grand King elect was conducted to the pedestal where he was Obligated



and he was then brought forward for Investiture, Installation and Proclamation by M.E.Comp. Rev. Canon Thomas H. Trimble, as the new Most Excellent and Supreme Grand King of the Supreme Grand Royal Arch Chapter of Ireland. M.E.Comp. S. Gordon Leathem BEM was saluted followed by sustained applause, all the Companions standing. The Most Excellent and Supreme Grand King thanked the Companions and proceeded to Install his Deputy.

The Grand Director of Ceremonies presented M.E.Comp. Rev. Canon Thomas H. Trimble to the Most Excellent and Supreme Grand King to be Obligated, Invested and Installed as Most Excellent Deputy Grand King. M.E.Comp. Trimble's sponsors were E.Comp. William P.H. Trimble and E.Comp. Harold Loughlin; his Stewards V.E.Comp. Alan D. McLorie and V.E.Comp. Cecil J.E.M. Wilson; Chair Bearer E.Comp. James Moore and Sceptre Bearer E.Comp. Geoffrey Browne. He was saluted and applauded, and he replied suitably.



Already it is 2019 so time to remember what happened in 2018. For the District Grand Royal Arch Chapter of Munster 2018 was a memorable year of highs and lows.

Traditionally the District Grand Royal Arch Chapter of Munster installs its officers in Mid-December, so we steal a little of 2017 for the 2018 installations. This event featured the usual promotions and the semi-permanent officers reinstalled. The meeting was sorry to hear our long-standing Treasurer give notice that 2018 was to be his last year, we will miss his expertise and service of many years, a job he has done with distinction.

January brought the start of the usual round of Chapter installations where some new Companions appeared, and old semi-permanent members continued. My thanks to my Deputy who covered some of these events and of course the District Inspector ever present to observe and help with Ritual.

Every year the District moves out to one of the country chapters for its April meeting. This year it was the turn of Skibbereen to host us. 


