Supreme Grand Royal Arch Chapter of Ireland Report 2019

2019 was another sad year for the Supreme Grand Royal Arch Chapter of Ireland and Freemasonry in general with the passing of the Past Grand

Registrar, R.E.Comp. Michael W. Walker. Having loyally and graciously served Freemasonry for over fifty years Michael, as he was affectionately known, passed away peacefully on 28th May 2019.

Michael entered Freemasonry in 1966 in Lodge No. 595 in Cork, but it was in Dublin that he spent most of his career until retiring as Grand Secretary and Grand Registrar in 2005. In between he was a member of Grand Master's Lodge, Royal Arch Chapter No. 728, Babylon Council of Knight Masons No. 6, University Preceptory, Original Chapter of Prince Masons and 28th, 30th, 31st, 32nd & 33rd Degrees of the Antient and Accepted Rite for Ireland.

Michael was also the architect of Lux Diei Lodge in 1988 when he had the foresight to establish the Lodge to cater for Brethren who find it difficult to attend evening meetings.

The foregoing is just the tip of the iceberg for it was as Grand Secretary of the Grand Lodge of Ireland and Grand Registrar of the Supreme Grand

Royal Arch of Ireland from 1981 to 2005 that most of us remember Michael.

However, it was in his role as Grand Secretary and Grand Registrar that he is most renowned. In his time, he served five Grand Masters and if truth be known he was the "de facto" Grand Master or at least had his hands on the reins of power.

Michael was a quiet, yet extremely efficient man and never sought the limelight, indeed he positively shunned it unless it was necessary not to. When one travels outside Ireland and his name is mentioned it is always with enormous respect and awe at the depth of his knowledge of Freemasonry and the quality of his advice as to how any matter, trivial or otherwise might be dealt with. Undoubtedly, his advice and opinions were keenly

When it was suggested that he might be appointed an Honorary Past Grand Master of the Grand Lodge of Ireland he summarily dismissed the thought and it was only when he was advised it was going to happen whether he liked it or not he reluctantly acceded to the suggestion. Any lesser

sought after and respected throughout the entire

world of Freemasonry.





honour would have been inappropriate for such a Giant in Freemasonry.

R.E.Comp. Michael bore his final illness with great fortitude and patience and was attending meetings until a very short time before his passing.

We will be missing a Giant of Freemasonry for we may never see his likes again, but he will never be far from our thoughts and be an example of how a Freemason might properly conduct himself.

At the February Convocation, by popular demand, the Companions of Youghal Royal Arch Chapter No. 68 celebrated the 275th Anniversary with the re-enactment of the Royal Arch procession in the port town of Youghal (27th December 1743). The Companions of Youghal Royal Arch Chapter No. 68 entered Grand Chapter carrying a "Royal Arch" to mark the event. Following the procession, the Excellent King of Youghal Royal Arch Chapter No. 68, E.Comp. David Butler explained the significance and quoted from the contemporary newspaper reports of 1743 and 1744. The Most Excellent and Supreme Grand King thanked the Companions of Royal Arch Chapter No. 68 for the excellent re-enactment.

The May Convocation took place in Londonderry and M.E.Comp. Ray Hetherington, District Grand King, welcomed the Supreme Grand King and

We do however have a number of new Master


Masons for our Craft Lodge who we have put through to Royal Arch this last year, the last of which we did in February hence our request to delay our installation to May which now could be delayed even further.


We hope 2020 will improve and that we are able to keep the Royal Arch Chapter going.


